

ADDENDUM TO CONTRACT (DATA PROCESSING ANNEX)

(hereinafter referred to as Customer)

(hereinafter jointly referred to as: Parties) as an addendum to the existing contract (hereinafter referred to as Contract) signed by the Parties on the date and place below.

Contracting parties agree to introduce an addendum to the Contract regarding their data processing activities pursuant to Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (so called General Data Protection Regulation - hereinafter referred to as GDPR).

Data processing, data protection

A Party may request the other Party to provide certain personal data (personal data of employees and personal data of data subjects of the fulfilment partners) for example the name, address, telephone number, e-mail address of the contact persons of the other Party in order to facilitate the fulfilment of the Contract between them. Parties have the right to store these data in databases available to their employees/agents and to use them, including but not limited to the financial administration, in order to fulfil the Contract.

Parties agree that they process and store the personal data of the employees and data subjects of the fulfilment partners provided to each other during the Contract period in accordance with the legitimate interest and in compliance with the applicable legislative provisions - in order to fulfil the existing contract between them and to keep contact - from the end date of the Contract until the end of the limitation period in order to settle any future disputes.

Contracting Parties undertake that the providing party is responsible for the personal data of the employees and the data subjects of the fulfilment partners set out above, therefore the providing party is obliged to provide information to the persons concerned regarding the processing of their data, their rights and a possible data transfer - necessary for the data processing.

Parties undertake that they shall get their employees and fulfilment partners to sign a confidentiality agreement about the processing and storing of the personal data provided by the other Party and require them not to take the personal data known to them upon termination of their contractual relationship.

Parties agree to take all the necessary technical and organisational measures in accordance with the legal provisions in force to ensure protection of the data. The natural persons concerned have the right to submit a written request for the copy of their data stored and to request the clarification or correction of their data by a written notification sent to the Party or to exercise their other rights provided under legislation. Parties shall act at all times in accordance with the data processing policy available on their webpage.

Parties are aware that the employees and natural persons data subjects of the fulfilment partners set out above have the right to object to processing of data or to request the restriction of data processing. With regard to the above, the Parties undertake that in case the employee/data subject of the fulfilment partner objects to processing of data and the given Party - after weighing the interests - decides to terminate the data processing, they are obliged to inform the other party without delay and in case the employee/data subject of the fulfilment partner requests the restriction of data processing, the Party concerned shall inform the other Party without delay in order to take the necessary measures.

Parties agree that, as set out above, they have the right to transfer the personal data provided by the other Party to their subcontractors and fulfilment partners lawfully used, as per Contract, and to which transfer they mutually agree by signing the contract.

By signing this addendum Customer declares that they understood, acknowledged and accepted the content of the data processing policy.

Parties agree that this addendum is in force from the date of signing and forms an integral part of the Contract. All other provisions of the Contract remain unchanged.

The parties duly signed this addendum, as it is in full accordance with their will.
